- Domestic Violence incidents: 3,100 last year (conservative) 20 % result in charges.
- 2005–2010 statistics are fairly steady
- Mary Ellen Turpell-Lafond completed a report in the fall to be released in April. A young child in BC was killed last year during a domestic violence incident.
